Further, SEBI has issued an Adjudication Order no. ORDER/BM/RK/2024-25/30315 dated April 30, 2024 ("Order"), under Section 15- I of the SEBI Act, 1992, read with Rule 5 of SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995 against the Company, imposing a penalty INR 5,00,000/- (Indian Rupees Five Lakhs only) for violation of provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR Regulations").

- 15. That the Company has not accepted/renewed or repaid any deposits under Section 73 of the Companies Act, 2013.
- 16. That the amount borrowed by the Company from the Public Financial Institution, banks and others was within the borrowing limits of the Company and the Company has filed necessary e-form for creation/modification/satisfaction of charges in that respect wherever applicable.
- 17. That the Company has not made any investments in other bodies corporate or persons falling under the provisions of Section 186 of the Act;
- 18. During the year, the Company has not altered the provisions of the Memorandum of Association and Articles of Association the Company;
