Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that the Company is undertaking 2 (two) de-bottlenecking exercises to further revamp its Container Glass Facility from 1,850 TPD to 1,900 TPD and enhancement of Speciality Glass Facility from 154 TPD to 200 TPD at an estimated capital expenditure of Rs. 47 crore. The increased capacity is expected to be commenced by March 2026.
